MINIATURE DOLLHOUSE CONTEST RULES AND REGULATIONS SECOND EDITION

1. GENERAL PROVISIONS

1.1 The aim of the contest is to promote reading, develop activity among the Readers, as well as promote the activities of the Foreign Languages Library located at 5 Meissnera Street in Warsaw.

1.2 To take part in the contest, the Entrant needs to access the Foreign Languages Library fan page – obcojęzyczna / foreign languages library on Facebook on April 23rd, 2020 (Thursday) at 6:30 pm, and correctly answer three questions.

2. THE ORGANISER AND DURATION OF THE CONTEST

2.1 The contest is organised by the Foreign Languages Library, a branch of the Zygmunt Jan Rumel Public Library in the Praga-Poludnie District of the Capital City of Warsaw, hereinafter referred to as WZO.

2.2 The contest will start on April 23rd, 2020 (Thursday) at 6:30 pm.

2.3 The contest will end, after receiving the first correct answer, to the three contest questions, in the comment section below the post containing the contest questions.

3. TERMS OF PARTICIPATION

3.1 The contest Entrant must be a natural person, over 16 years of age, and residing in the Republic of Poland.

3.2 The contest Entrant is obliged to read the Contest Rules and Regulations.

3.3 By entering the contest, each Entrant accepts the Contest Rules and Regulations.

4. CONTEST RULES

4.1 The winner will be the first person, to give the correct answer, to all three questions in the comment section of the post containing the questions, which will be published on April 23rd, 2020. In the absence of correct answers, the person whose answers will be closest to the right ones will win.

5. CONTEST RESULTS AND PRIZE AWARDING

5.2 The results of the contest will be announced on www.bppragapd.pl, and on the WZO Facebook fan page – obcojęzyczna / foreign language library on April 27th, 2020.

5.3 The prize will be sent by Poczta Polska, to the address indicated by the winner of the contest, however it must be within the Republic of Poland.

INFORMATION ON THE PROCESSING OF PERSONAL DATA

In accordance with article 13 paragraph 1 and paragraph 2 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 /EC (General Data Protection Regulation) hereinafter referred to as GDPR, we would like to inform:

1. The administrator of personal data is the Zygmunt Jan Rumel Public Library in the Praga-Poludnie District of the Capital City of Warsaw with headquarters located at 5 Meissnera Street (post code: 03-982), as well as Facebook Poland Sp. z o.o.
2. The Zygmunt Jan Rumel Public Library has appointed a Personal Data Protection Officer, who can be contacted by telephone: 22 671 04 51 ext. 104 or via email: iodo@bppragapd.pl.
3. The Entrant's personal data will be processed on the basis of art. 6 par. 1 let. f GDPR in order to promote reading, develop activity among the Readers and to promote the activities of the Foreign Languages Library, as well as to conduct the Second Edition of the Miniature Dollhouse Contest along with naming the winner and publishing the information on the Library's website and on the Library's Facebook account; The scope of data is: name and surname, home address and nickname used on Facebook. The home address will not be disclosed publicly, but will be needed, to be able to send the prize.
4. Providing data is voluntary, but it is prerequisite in order to participate in the contest. If the Entrant does not provide the data in question, he/she will not be able to participate in the contest.
5. The Entrant has the right to access his/her data, to rectify it, delete it and to limit its processing. He/She also has the right to object, the right to withdraw consent at any time without affecting the lawfulness of the processing that was carried out on the basis of consent before its withdrawal.
6. The Entrant's personal data will be stored for the duration of the contest, and then for 3 years from the date of the end of the contest.
7. The Entrant has the right to lodge a complaint with the supervisory body, i.e. the Personal Data Protection Office, if he/she considers that the processing of your personal data violates the provisions of the general regulation on the protection of personal data of April 27, 2016.
8. The provided data will not be subject to profiling;
9. Personal data will not be disclosed to other recipients.
